## **Don't Fly Your Drone at Super Bowl 50: "Know Before You Fly" Reminds UAS Users to Respect Temporary Flight Restrictions**

*Education Campaign Urges UAS Operators to Adhere to TFRs, Safety Guidelines during Football's Big Game*

**WASHINGTON** — Know Before You Fly today reminded unmanned aircraft systems (UAS) operators and model aviators to respect temporary flight restrictions (TFR) in effect around Super Bowl 50 on Feb. 7. There will be a TFR around the big game, which goes into effect at 2 p.m. PST and lasts until 11:59 p.m. PST. During this time, model aircraft and drones will be prohibited from flying within a 32 nautical mile radius of Levi's Stadium in Santa Clara, California.

The Super Bowl TFR is expansive because the big game is considered a special security event, but it's not just the Super Bowl that's subject to flight restrictions. The FAA typically restricts the airspace around sporting events with a seating capacity of 30,000 or more, including concerts, major league baseball and motor speedway events. TFRs are also issued for presidential visits and during natural disasters or hazards, such as wildfires. More information about the types of TFRs may be found [here](#).

When TFRs are not in place, Know Before You Fly would like to remind flyers to follow these guidelines to keep the skies safe for all:

- Fly no higher than 400 feet
- Fly within visual line of sight
- Stay well clear of other aircraft
- Never fly within 5 miles of an airport without contacting airport authorities or air traffic control
- Keep well away from emergency response efforts, such as fires
- Beware of FAA airspace requirements (<http://www.faa.gov/uas/tfr/>)
- Don't fly under the influence
- Make sure to register before your first flight (<http://knowbeforeyoufly.org/register-your-drone/>)
