Give Brief Summary of the Proposed Change:

Rule 7.2.3 requires a 10-second launch window spanning from the beginning of the initial buzzer to the END of the second buzzer. This would be difficult to implement and is almost certainly unintended. The original 10-second window requirement was meant to extend from the beginning of the initial buzzer to the beginning of the second buzzer. In other words, it was intended that if you hear the second buzzer and are still holding your plane then you're too late.

7.2.3. Launching is to be done within a 10-second launch window. The flight is initiated during or after the initial "10 second launch window" buzzer. All pilots must launch their planes before the second launch window buzzer. A plane launched before the initial buzzer sounds or not launched before the second buzzer sounds will receive zero points for the round.

State logic behind proposed change, including alleged shortcoming of the present rule(s).

An early version of the 2017 rules said this:

7.2.3. Launching is to be done within a 10 second "Launch Window". The flight is initiated with

an initial "10 second launch window" buzzer. All pilots must launch their planes before the second launch window buzzer. A plane launched before or after the launch buzzer will receive 0 points for the round

The original intent was clear in the third sentence, but the fourth and final sentence was poorly worded and clearly needed to be corrected. However, in the course of correcting the final sentence the original intent was lost.
