Give Brief Summary of the Proposed Change:

Remove a set of inappropriate specific maneuver parameters from the CL Precision Aerobatics Rule Book Judges' Guide, Paragraph 14.7.2, second sentence which now reads:

"Therefore, although it is not possible for judges to accurately measure whether or not a model aircraft has or has not made a turn of between 1.5 (4.9 feet) and 2.1 meters (6.9 feet) radius, the intent of the maneuver descriptions is clearly that a model aircraft should turn as tightly as possible when making such turns."

State exact wording proposed for the Competition Regulations. List paragraph number where applicable. Example: Change "quote present rule book wording" to "exact wording required".

Change the CL Precision Aerobatics Rule Book Judges' Guide, Paragraph 14.7.2, second sentence to read:

"Therefore, although it is not possible for judges to accurately measure how sharply a model turns in those maneuvers which require turns "of a tight radius", the intent of the maneuver descriptions is clearly that a model aircraft should turn as tightly as possible when making such turns."

State logic behind proposed change, including alleged shortcoming of the present rule(s).

The maneuver descriptions of Paragraph 13 define how the various maneuvers are to be flown with appropriate requirements and parameters defined for each maneuver. As stated in the Judges' Guide Paragraph 14.1.1, Paragraph 13 takes "precedence over any differences that might appear in this Judges' Guide". In the maneuver descriptions of Paragraph 13, there is no specification for the turn radius for any maneuver that has "corners of a tight radius". The parameters that need to be deleted from Paragraph 14.7.2 as explained above are a hold over when those corners were previously defined to be 5 feet Those

5-foot radius requirements were removed from the maneuver descriptions in Paragraph 13 many years ago. The Judges' Guide is no place to specify a specific turn radius not mentioned in Paragraph 13.
